According to the Organic Act on the Prevention and Suppression of Corruption B.E. 2561 Section 128 paragraph one prescribes that any state official is prohibited from accepting assets or any other benefits that may be Calculated as income from whom? other than assets or benefits that are legitimate by laws, rules or regulations issued by resident power under the provisions of the law except receiving property or any other benefits with ethics according to criteria and limits the number determined by the NACC and the code of ethics Police Officers 2021 Article 2(2) Honesty perform legal duties Schemes of Royal Thai Police with transparency Do not show the behavior that implies exploitation. Therefore, in order to prevent conflicts between personal and public interests (Conflict

of Interest) accepting bribes, gifts, tokens or other benefits which affects the performance of duties, therefore Anti-Bribery Guidelines (Anti-Bribery Policy) and not accepting gifts, gifts or any other benefits (No Gift Policy) from performing duties The details are as follows:

Clause 1: This announcement

"Supervisor" means a person who has the authority to direct, supervise, and follow up

and check the police officers under the affiliation (can be adjusted according to the wording of the police)

"Bribe" means property or any other benefit given to a person in order to induce that person to commit an act. act or not act perform any act in the position, whether it is rightful or wrongful

"Performance of duty" means an act or performance of a duty of a government official in

appointed position or assigned to perform any duty or to act instead in Any duty both general and private Acting only as a police officer for which the law is stipulated. duties or is an act in accordance with the powers and duties specified by the law to have the power Authority of the police

"gifts, tokens or any other benefits that affect the performance of duties" means money

Property, services or any other benefits that are valuable and include tips by government officials in addition to salaries, income, benefits from government service in normal cases and affecting decisions, approvals, permissions or perform any other duty in a manner that contributes to dishonest benefits to the gift giver either in the past or while receiving or in the future

Clause 2: Surveyors at all levels conduct themselves as follows:

2.1. Do not ask Na, do not give or accept bribes, gifts, tokens or any other benefits from

duty

2.2. Do not consent or conspire for family members to give or receive bribes, gifts, tokens. or any other benefits to those involved in the performance of duties

2.3. Performance of duties must be based on Law enforcement with fairness based on benefits and the image of the police is important. and public benefits such as accepting gifts, tokens or any other benefits that affect the performance of duties, The use of central government resources for personal benefit , Disclosure of internal information , The encroachment of official time for special work, etc.

2.4. Reduce the giving or receiving of assets or other benefits ethical in accordance with the criteria and the amount determined by the Office of the NACC, using the method of expression by signing greeting cards, greeting books condolence card or using social media instead of giving things

2.5. Do not tolerate, tolerate, or be indifferent to the behavior of accepting bribes, gifts, gifts or other benefits. from performing duties If any action is found violations to inform the commander/station chief as soon as possible

Clause 3: Commanding officers have the power to has the authority to supervise, follow up and inspect police officers under to conduct themselves in accordance with this announcement In the event that an action is found Violators of this announcement must report to the Superintendent /The Station Chief knew it quickly

Clause 4: Anyone who finds acts that violate this announcement Complaints / clues can be reported directly. with the Station Superintendent Thung Khao Luang Provincial Police or by telephone number 087-944-7557, which information of Complaints/Whistleblowers will be concealed and kept strictly confidential

Clause 5: In case of receiving complaints/clues, personnel under the committing such offenses at the police station will conduct a fact check and if found Offenders will be punished for doing such acts. Strictly comply with relevant laws, rules and regulations. and send the matter accordingly hierarchy of command next
